

OZZ MEDIA CORP.'S WEBSITE PRIVACY POLICY

Last revised: September 1st, 2010

This Website Privacy Policy (this "Privacy Policy") governs your access and use of the websites located at www.OZZmediacorp.com and www.OZZmedianetwork.com and <http://forum.OZZmedianetwork.com> (the "Sites"). OZZ media corp owns and operates these Sites.

As a result, this Privacy Policy is intended to comply with applicable privacy legislation in a manner that is open and transparent.

IT IS IMPORTANT THAT YOU READ ALL OF THE TERMS AND CONDITIONS CAREFULLY.

1. Acceptance of Terms

By accessing and continuing to use these Sites, and by providing certain Personal Information (as hereinafter defined) to OZZ through these Sites, you are indicating your acceptance to be bound by the terms and conditions of this Privacy Policy. If you do not accept these terms and conditions, please do not access or use these Sites, or provide Personal Information through these Sites.

2. Modifications and Notices

OZZ may revise this Privacy Policy, at any time, by updating this posting. OZZ may provide notice to our users of such revisions by means of a general notice on these Sites. Continued use of these Sites after such revisions are posted will signify your agreement to these revised terms. Therefore, you should visit this page periodically to review this Privacy Policy.

3. OZZ Respects Your Privacy

OZZ is committed to protecting the privacy of all of our users of these Sites and maintaining the integrity of any personally identifiable information ("Personal Information") that we collect, use, retain or disclose via these Sites. The purpose of this Privacy Policy is to inform you how and why we collect Personal Information on these Sites, to outline the steps we take to safeguard your Personal Information, and to provide you with an OZZ contact number should you have any questions or concerns about our privacy practices.

4. General Information

Our Internet servers may passively and automatically collect certain information about users' online traffic patterns, which may be linked to their Internet Protocol (IP) addresses (which are unique Internet "addresses" assigned to all Internet users by their Internet Service Providers). Server logs may record statistical information, such as users' IP addresses, type of operating systems, time and duration of visit, pages requested, and identify categories of users by items such as domains and browser types. Such statistical information is generally collected and used by OZZ in a manner that does not identify users of these Sites.

These Sites may use "cookies". Cookies are small text files offered to your computer by servers in order to keep track of your browser as you navigate a website. Cookies may be stored on your hard drive, or in temporary (cache) memory in which case they are deleted when you shut down your browser or turn off your computer. We may use cookies to record session information, such as your browsing habits and past activity, to enable us to provide you with improved services such as customized webpage content. You can disable cookies using your

Internet browser's settings. Please consult your browser's help function for information on how to disable cookies. Note that if you disable cookies, certain features of these Sites may not function properly.

These Sites may contain links to other websites that are provided as a convenience only, and which may have different privacy policies and practices than OZZ. OZZ has no responsibility for such third party websites, and you are advised to review the privacy policies of any third party websites you choose to visit.

5. Why does OZZ collect your Personal Information?

OZZ collects Personal Information only for the following purposes:

- to identify individuals;
- to carry out online contests and promotions including feedback sheets;
- to communicate with users;
- to enable communication amongst people on the OZZ forum;
- to advertise, develop, enhance and provide services and products to users;
- to measure and improve the effectiveness of OZZ's services, products and marketing endeavours;
- to manage and develop OZZ's business operations, including to manage proposed or actual sales or leases of all or part of OZZ's business or assets;
- to protect users and OZZ against error and fraud; and
- to achieve any other purpose to which users have provided their consent or as required or permitted by law.

Further reference in this Privacy Policy to "Identified Purposes" means the reasons set forth above.

6. Does OZZ disclose your Personal Information?

OZZ does not disclose Personal Information to third parties for any other purposes other than those for which it was collected, except with your consent or as required or permitted by law.

There are a variety of circumstances where we may need to disclose Personal Information to third parties. For example, OZZ may disclose Personal Information to a third party engaged by us to perform functions on our behalf or to a public authority or agent of a public authority if, in the reasonable judgment of OZZ, it appears that there is imminent danger to life or property which could be avoided or minimized by disclosure of the information.

In situations where we disclose Personal Information in accordance with this Privacy Policy to third parties, we do not disclose more information than is required and, where it is reasonable and practical to do so, enter privacy agreements with third parties with whom we disclose Personal Information.

7. How does OZZ safeguard your Personal Information?

OZZ uses various means to help safeguard your Personal Information. Only authorized employees and agents have access to Personal Information. OZZ employees who have access to Personal Information receive training regarding privacy protection. All computers on which Personal Information is stored are password protected.

8. Your Consent/Verifying and Amending Personal Information

You may withdraw your consent for OZZ to manage your Personal Information in a particular way, subject to legal or contractual restrictions and reasonable notice. However, this may limit our ability to provide you with certain services and/or products. You may contact OZZ for more information regarding the implications of withdrawing consent.

You can also access and review your Personal Information held by OZZ and make appropriate changes to it by contacting OZZ. You may be required to put your request in writing and show us identification. The reason we ask for identification is to ensure that, among other things, we do not unintentionally release your Personal Information to a third party who is representing him/her as you.
